Any Georgia taxpayer can redirect part of your taxes to NHND.

What

Georgia SSO or Georgia Student Scholarship Organization Inc. is a state registered Student Scholarship Organization (SSO) as well as a 501-C-3 non-profit organization whose function is to facilitate the process of distributing tax credits in exchange for donations and to distribute funds for private school tuition scholarships. Georgia SSO partners with over 135+ Georgia private schools and has provided more than \$62 million dollars in tuition scholarships supporting preK-12th grade.

When

This year the deadline is approaching quickly. We need to finish pledging in the month of October (early November). In 2024 we can start again in May.

Where

georgiasso.com has all the info you need to pledge.

Why

Scholarships cover tuition and fees to help lower out of pocket tuition and cover school fees to help improve yourß school.

How

Pledge now, Pledge the Max, making sure your name is the same name on your tax return. Then after you are approved in January, you will be notified to contribute to Georgia SSO. You will receive a tax credit receipt to use to claim your 100% dollar for dollar tax credit.

How much

No amount is too small. Look back at what you paid in Georgia taxes last year. Or use this calculation: 5.75% of your Adjusted Gross income. The maximum is listed on the website.

Who will benefit

Parents and the entire school. Many students at NHND will be eligible for a scholarship and many new students as well. Through this program, NHND will also be able to get school improvement fees.

What should I do now?
